The parents may admit their children as per the schedule mentioned below failing which their claim for the seat will be forfeited and no further correspondence will be entertained in this regard. They are requested to follow COVID-19 Protocols in the wake of COVID-19 Pandemic during admission inside school premises.

The following documents are to be submitted in original along with self-attested copies. Original documents may be retained and returned after due verification.

- 1. Hard Copy (Print Out) of the Online Application Form**
- 2. Birth Certificate showing date of birth, name of the Parents and the child**
- 3. Proof of Residence (Any proof issued by the government/government agency in the name of the parent of the child). Those who are staying in rented house must submit copy of rent agreement along with photocopy of LPG Gas Card or Electric Bill in the name of Parent**
- 4. Aadhar card of child and Parents**
- 5. Self-declaration about the distance of the residence from KV Boudh (The format may be downloaded from the Vidyalaya Website)**
- 6. Three passport size photographs**
- 7. SC/ST Certificate issued by the competent authority (Certificate in the name of the parent may be accepted) – If it is in the name of the parent an undertaking should be submitted to produce the certificate in the name of the child within **03 months** from the date of admission (The undertaking format may be collected from I/C admission)**
- 8. Latest OBC(Non-Creamy Layer) Certificate issued by the competent authority – should not be older than Three year i.e. it should be issued on or after 01.01.2018 (It should be in the name of the child for whom admission is sought, If it is in the name of the parent an undertaking should be submitted to produce the certificate in the name of the child within **03 months** from the date of admission (The undertaking format may be collected from I/C admission) – SEBC Certificate will not be accepted in lieu of OBC Certificate.**

9. Those claiming admission under EWS should submit valid EWS Certificate along with **income certificate** issued by the competent authority (It should not be older than one year and it should be issued in the name of the parent of the child only).
10. Those claiming admission under BPL , BPL Card Should be in the name of the parent of the child only – Ration Card, NFSA Card will not be accepted in lieu of BPL Card.
11. For differently abled candidate , The candidates have to produce valid disability certificate issued by competent authority not less then the rank of CDM & PHO
12. Service Certificate(format downloaded from Vidyalaya Website), First page of service book showing particular of employee (Photo Copy authenticated by DDO Or Head of Office) Pay Slip and Transfer Order(Applicable for permanent working parent of Service Category-I, II, III, IV)
13. For Ex-Service Man – Transfer details counter signed by the Zilla Sainik Board or by the competent authority (**Format available in the Vidyalaya Website**), copy of the ID proof of ex-Service man and the pension book.
14. For Single Girl Child – Latest affidavit sworn before the First Class Magistrate. Signed by both the parents.
 15. Blood Group report of the child
 16. E-MAIL Address of the parents and their Whatsapp number
 17. Any other documents as required by the admission committee as per the demand of the situation.

NOTE: The documents from Sl. No. 1 to 6 are compulsory for all and Sl.No. 6 to 17 are for the cases wherever applicable
