- SC/ST Certificate issued by the competent authority (Certificate in the name of the parent may be accepted) – If it is in the name of the parent an undertaking should be submitted to produce the certificate in the name of the child within 03 months from the date of admission (The undertaking format may be collected from I/C admission)**
- Latest OBC(Non-Creamy Layer) Certificate issued by the competent authority – should not be older than Three year i.e. it should be issued on or after 01.01.2018 (It should be in the name of the child**
