- SC/ST Certificate issued by the competent authority (Certificate in the name of the parent may be accepted) – If it is in the name of the parent an undertaking should be submitted to produce the certificate in the name of the child within 03 months from the date of admission (The undertaking format may be collected from I/C admission)**
